ORDER MADE AFTER APPLICATION

BEFORE

(THE HONOURABLE)

(MADAM JUSTICE DORGAN)18 FEBRUARY 2015

ON THE APPLICATION of the petitioner, the Law Society of British Columbia (the "Law Society"), filed 25 July 2014, coming on for hearing at Vancouver, British Columbia, on 18 February 2015, and on hearing Michael J. Kleisinger, lawyer for the petitioner, and Wayne L. George, lawyer for the respondents, and after reviewing the materials filed in this matter and reading the Agreed Statement of Facts presented at the hearing:

THIS COURT ORDERS THAT:

- The respondents, Robert G.D. Gallard ("Mr. Gallard") and Gallard's Collection Service Ltd. ("Gallard's Collection") are found in contempt of the order pronounced in this proceeding on August 14, 2007.
- 2. On or before July 2, 2015, Mr. Gallard will pay a fine to the court in the amount of \$2,500.
- 3. On or before September 1, 2015, Gallard's Collection will pay a fine to the court in the amount of \$5,000.
- 4. On or before July 3 and September 2, 2015, the respondents will provide the Law Society with proof that they have paid their respective fines to the court.
- 5. Mr. Gallard, until such time as he becomes a member in good standing of the Law Society, and Gallard's Collection are permanently prohibited and enjoined from commencing, prosecuting or defending a proceeding in any court, except as an individual party to a proceeding, acting without counsel, and solely on his or its own behalf.

- 6. Mr. Gallard, until such time as he becomes a member in good standing of the Law Society, and Gallard's Collection are permanently prohibited and enjoined from:
 - (a) appearing as counsel or advocate;
 - drawing, revising or settling a document for use in a proceeding, judicial or extra-judicial;
 - (c) drawing, revising or settling a document relating in any way to a proceeding under a statute of Canada or British Columbia;
 - (d) doing an act or negotiating in any way for the settlement of, or settling, a claim or demand for damages;
 - (e) giving legal advice;
 - (f) making an offer to do anything referred to in paragraphs (a) to (e); and
 - (g) making a representation that they are qualified or entitled to do anything referred to in paragraphs (a) to (e)

for or in the expectation of a fee, gain or reward direct or indirect, from the person for whom the acts are performed.

7. On or before February 20, 2015, the respondents will pay \$5,550 to the Law Society representing its special costs.
